Guest Speaker: **Emily Plotkin - MOSAIC**

Mosaic in Colorado Springs oversees services for over 100 people with intellectual and developmental disabilities (IDD) in the Pikes Peak Region.

The service agency was established under the name "Martin Luther Homes" in Colorado Springs in 1979 and in 2003, when the organization merged with Bethphage, became a Mosaic agency.

Services provided by the agency include:

- Independent and live-in residential support
- Community access
- Skill-building assistance
- Behavioral assessments and support

Mosaic is the largest, faith-based nonprofit providing these kinds of services to people with IDD in the United States and is a best-practice resource for the United Nations regarding policy that relates to people with special needs.

Emily Plotkin is the Community Relations Manager for Mosaic in Colorado Springs, and has served Mosaic in that position since November 2015.

Emily is originally from Portland, Oregon and before coming to Colorado and joining Mosaic, worked with a network of community clinics in the Portland Metro Area.

While her work with Mosaic is varied, a key function of her role is building community support for Mosaic and educating the public about the importance of the work they do.

Many misconceptions still exist about people with special needs, and Mosaic makes every effort to connect people with the communities in which they live, breaking down barriers and providing opportunities for enrichment and understanding.
