By the time our March Chapter meeting is called to order the Colorado political caucuses will have already taken place. These events are not the end but the beginning months of preparation, discernment, self-education, and debate leading towards the exercising of our civic duty as voters of our republic. Our decisions will determine how our local, state, and federal bodies will influence our existence in almost every aspect of our lives.

Acknowledging that Knights are foremost Catholic citizens it is worth reminding ourselves of some do's and don'ts as we continue along the election process. I believe one of the most important reminders is that not every member of a council or assembly holds the same political outlook and as such we need to respect everyone's opinions.

Discussion of political issues should be carried out with mutual respect and open mindedness and never forced on fellow brothers who don't wish to participate in such discussions. Therefore, remember that unless discussing an issue of importance to our bishop, State KofC or Supreme KofC political subjects should not be included in official council or assembly agendas.

That being said the Order does encourage all personnel to participate in the democratic process and become involved in personal political activities even though we realize we do so in a personal capacity and not on behalf of the Order. Lastly, though it is probably not necessary to say so, remember our oath to be loyal to the teachings of Holy Mother Church. Issues such as pro-life, protection of religious freedoms, school board approved sex education curricula, to mention just a few issues should be considered when selecting a potential elected official by examining a candidate's stance on such issues. Besides being the best informed through examination of a candidate's stances by reading, asking questions, attending information sessions it is equally if not more important to pray. Pray for guidance, pray for a strong moral local; state; and federal government, and pray for God's blessings and protection for our great and wonderful country.
